

# **UNDERCRANKED LTD. BOOKING TERMS AND CONDITIONS 2022**

Undercranked Ltd. Terms and Conditions of business are shown below. By working with us you agree to comply with these Terms and Conditions. In addition, our Data Privacy Policy (DPP) and Data Processing Agreement (DPA), which come into effect on 25<sup>th</sup> May 2018, are to be taken and included as part of these Terms and Conditions from that date (See below). Any negotiated changes, additions or deletions to these Terms and Conditions shall be confirmed in writing. References to The Agent or Agency within the Terms and Conditions means Undercranked Ltd.

## General

- Exact work Terms and Conditions negotiated and agreed by The Agent and The Client on behalf of Crew/Talents may differ taking into account the specific needs of each particular Job.
- To proceed and 'Confirm' status on any project, The Agency requires written booking agreements and/or contracts in place, during office hours, no later than 3pm on the day prior to initial work date.
- Talents, crew, equipment and corresponding costs and prices are subject to availability prior to confirmation.
- Outside of narrative and long form productions, Undercranked contracts and company Terms and Conditions remain as
  overriding.
- Company relevant Non-Disclosure Agreements are reviewed at the discretion of The Agency and will only be accepted following hire.
- For productions outside of those within APA, Talent and Crew are normally hired for a 10+1-hour day with overtime charged as a standard 1.5 per hour (presence onsite including a 1-hour lunch break, unless otherwise specified). Pre-call time and incomplete lunch break is subject to overtime charge at the agreed hourly overtime rate.
- Unless otherwise agreed, in the event an HOD (Head of Department) fee is accepted below and outside of industry guidelines, including BECTU, PACT and/or APA, The Client will be charged an agency fee of 20% on the agreed daily rate.
- Where a 'Buyout' is agreed, separate details will be confirmed in writing. All buyout's must be paid in full during office hours,
   24-hours in advance of call, recce, or travel time.
- Additional services should be discussed, agreed, and confirmed in writing.

# **Crew/Talent Contact**

- All discussions and subsequent agreements concerning any particular job or upcoming jobs must be made with and via The Agent. This includes but is not limited to Terms and Conditions, meetings and phone/ Skype calls required prior to job confirmation, and all workdays.
- Following agreement, The Agency will be able provide Crew ID and contact information to The Client upon confirmation of the job.
- The Client shall 'cc' The Agent into all written communication with The Crew/Talent.
- All Crew and Talent contracts are negotiated by Undercranked and will be reviewed by all parties prior to final agreement and confirmation.

# Insurance

- All insurance including public and employer's liability, and/or production insurance will be provided by The Client. This should be confirmed in writing as part of each agreement.
- In the event equipment is required/instructed by The Client and hired via Crew/Talent, Client insurance cover will be confirmed and provided by The Client.

# **Transport Expenses**

- Unless agreed otherwise, The Client will be responsible for the cost of parking and congestion charges, travel expenses and transport cost (Petrol will be charged at 45p per mile).
- In the event travel is incurred outside of the M25 prior to call time and following wrap, The Client will be charged door to door at an hour rate of time and a half of the daily rate agreed.
- In the event catering is not provided a standard per diem meal cost or food expenses will be provided.

# **Data Regulations**

 When booking our Talents, you will provide data and job and assignment details. In providing these details, you accept our Data Protection Policy and Data Processing Agreement (Both found online at our website: <a href="http://www.undercranked.net/pages/about">http://www.undercranked.net/pages/about</a> or by request to assistant@undercranked.net

# Conduct

• Crew and Talents will endeavour to be hospitable and polite, and dress appropriately to the circumstances and the client is expected to behave in a similar manner.



## Other

• The Client should notify The Agent of any work or job issues as early as possible prior to the job completion in order to allow any problems to be solved in a timely manner.

# **Invoicing and Payment Terms**

- Full payment is required upon completion of all shoots and invoices will be issued and paid in Pounds Sterling (GBP) or otherwise if agreed in advance in writing.
- All feature film payment terms are standard 7-days upon invoice and outside of these, the usual payment terms apply at 30days upon receipt of invoice or as otherwise agreed.
- Alternative arrangements for payment may be made at the sole discretion of The Agent prior to job confirmation.
- 7-days payment terms may also apply to new Clients and, unless agreed otherwise, new Clients are expected to pay a minimum of 50% 24-hours in advance on a job call-time or travel day.
- Unless agreed otherwise, buyouts require payment in full 24-hours in advance of call or travel time.
- In the event payment is frequently overdue by The Client, The Client may be expected to pay in advance for future bookings. The Invoice date and client contact address in accordance with the associated booking agreement will not be changed following receipt of invoice.
- Notwithstanding the fact that Purchase Orders may be an administrative necessity for The Client, we require full payment in accordance with our contract.
- In the event of late payment Undercranked reserves the right to claim 8% statutory interest over the base rate as specified by UK Law.
- Unless advised otherwise, in the event payment is overdue by 30-days or more, formal action will be taken by Undercranked against the Client in order to source outstanding monies.

## **Cancellation Fees**

Upon signing a 'Booking Agreement' the job will be deemed as 'Confirmed'. Unless agreed otherwise, all booked and confirmed Assignment time is subject to cancellation charges at the following rates"

- 7 and more days prior to the engagement: no cancellation fee applies
- 6-4 days to the engagement: 50% of the agree fee will be charged
- 3-2 days to the engagement: 75% of the agree fee will be charged
- On day prior to the engagement: 100% of the agreed fee will be charged
